

RELEASE OF LIABILITY – READ BEFORE SIGNING

In consideration of my minor child/ward _____ (“my child”) being allowed to participate in this sports camp/clinic program, its related events and activities,(Clinic Date & Name)_____ I, the undersigned, acknowledge, appreciate, and agree that:

1. The risk of serious injury from the sports activities involved in this program is always present due to the nature of the sport(s); and
2. FOR MYSELF, SPOUSE, AND CHILD, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my child’s participation; and
3. I willingly agree to comply with the program’s stated and customary terms and conditions for my child’s participation. If, however, I observe any unusual significant concern in my child’s behavior, readiness for participation and/or in the program itself, I will remove my child from participation and bring such to the attention of the nearest official immediately; and
4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS the course, Lock Golf Academy, their officers, officials, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used for activity (“Releases”), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
5. I hereby certify that my child is in good health and physically able to participate in all activity. I agree to follow all state and local health orders that apply to MI Safer Sports COVID-19 guidelines, including wearing a face mask when around others, limitations on gatherings outside my immediate household, including non-team gatherings and social gatherings with my team outside of practice or competition.
6. I understand that failure to follow the above agreements could result in my removal from clinic, competition and practices and may result in disqualification of my entire team.
7. My child and I agree to abide by the rules and regulations of Lock Golf Academy and Tanglewood Golf Club. I agree that my child will abide by the rules and realize that any breach of the rules may result in his/her immediate dismissal without refund of any fees.
8. I grant Lock Golf Academy permission to use photos or video taken of me or my child for advertising purposes.

Guidelines and Policies

Clinic Attire & What to Bring:

- Students should dress appropriately for changing weather conditions during session.
- Comfortable footwear such as sneakers or golf shoes (no football cleats or sandals)
- Summer heat and sun is always an issue. Students should bring: Sunscreen, head cover, and water bottle.
- Bring Golf Clubs to each class.

Safety:

- Safety is our first priority with all of our programs. Students who do not observe the following rules will be discontinued from the program if the instructor deems their behavior unsafe.
- Swing only when instructor permits it.
- Suspend all activity when “Time Out” is given by the instructor.
- Strict observance of all range and course rules outlined in clubhouse.
- Respect for other golfers in clinic
- Wear a mask during clinic and stay 6 feet away from other participants.

Payment and Cancellation Policy:

Payments can be made via credit, cash or check made payable to Dan Lock and are due when registering. Junior golfers must have release form signed by guardian to participate on or before clinic start date.
